



## The 2018 YRAP Winter Camp December 27-29th, 2018

Morven Park, Leesburg VA

Morven Park in Leesburg Va will host the 2018 YRAP Winter Camp with lead instructors being Skyeler Voss and Stephen Bradley with a guest lecturer each day. Riders will receive three days of instruction (5-6 mounted lessons and at least 2 lectures). A demonstration and/or guest speakers will occur each day over lunch. Weather permitting a XC session maybe held on the property or we will trailer to Loch Moy (30 minutes north east).

The camp is open to all riders and of all levels and is NOT restricted to Young Riders. Auditors are welcome at no cost. Dress warmly. We will work indoors only if absolutely necessary.

### Cost for Camp:

\$500 Cost includes 3 days of instruction, afternoon demos and talks, snacks and stabling and facility fees at Morven Park. \$200 deposit is required to reserve a spot. Remaining balance is due by December 23th for spot to be confirmed. Riders are welcome to bring an additional horse for use in an additional session each day at a reduced fee of \$400. Payment via check preferred. PayPal accepted with additional \$15 fee. Simple lunch will be provided each day or bring your own. Cost does not include housing, shavings, grain, hay, etc. but a Tractor Supply is close.

There is no discount for ship-ins who do not use a stall.

Cancellation due to weather: Full Refunds will be given. Scratches for reason: A full refund will be given if spot can be filled. Otherwise refund less \$200. Camp is limited to 25 horses.

**From North:** US 15 South toward Leesburg, before split - Right on Rte 740-Tutt Lane (1 mile north of town, just before Leesburg bypass) travel 8/10 mile to Sunday Morning Lane on left.

**From South:** US 15 North just outside of Leesburg turn Left on Rte 740-Tutt Lane (200 yards after end of Leesburg bypass) – travel 8/10 mile to Sunday Morning Lane on left. DO NOT follow signs in Leesburg for "Morven Park".

I understand that my participation involves all inherent risks associated with the dangers and conditions which are an integral part of equine activities, including, but not limited to, the propensity of equines to behave in ways which may result in injury, harm or even death to humans or other animals around or near them; the unpredictability of equine reaction to sounds, sudden movements, smells, and unfamiliar objects; persons or other animals; hazards related to surface and subsurface conditions; collisions with other equines or objects; and, the potential of a participant to act in a negligent or unskilled manner which may contribute to injury to the participant or others, including failing or inability to maintain control over the animal. By participating in this activity I agree to assume responsibility for those risks, and I release and agree to hold harmless the activity organizer, organizing committee, officials, the USEA, USEF, their officers, agents, employees and the volunteers assisting in the conduct of this USEA educational activity and the owners of any property on which it is to be held, from all liability for negligence resulting in accidents, damage, injury or illness to myself and to my property, including the horse(s) which I may ride.
